

SENIOR DATA ANALYST

Summary

The Child Health and Development Institute (CHDI) is seeking a **Senior Data Analyst** to work on projects related to performance improvement in children's behavioral health. A key component of ensuring the delivery of high-quality and effective services is collecting, analyzing, and reporting data to promote fidelity, quality, and outcomes. The Senior Data Analyst will be responsible for receiving, cleaning, analyzing, and reporting data to support quality improvement projects in children's behavioral health, including outpatient services, Evidence-Based Treatments, and the Functional Family Therapy- Foster Care program.

The ideal applicant will be proficient in database management, data analysis, and reporting. The individual selected for this position will work within grant- and contract-funded projects at CHDI. Opportunities to contribute to CHDI and external publications may be available.

Required Education and Skills

- Bachelor's Degree (master's degree preferred) in biostatistics, psychology, public health, child development, or a closely related field;
- Intermediate to high level of experience in receiving, cleaning, and organizing large data sets using SPSS, Excel, and Power BI;
- A high degree of proficiency with database management, data analysis and statistics, including hands-on experience modifying and maintaining syntax, formulas, and scripts;
- Experience identifying data trends and writing reports that present data and describe findings;
- Excellent interpersonal, communication, and time management skills;
- Experience creating and managing large data systems used to collect provider-level data;
- Knowledge of and/or lived experience with the children's behavioral health system and/or the child welfare system is preferred but not required
- Additional skills and experience that are preferred, but not required, include: supervisory experience; managing and maintaining online database systems; experience with online survey tools (e.g. Alchemer); QGIS/mapping; evaluation methods; quality improvement methods; program implementation; advanced statistical analysis; evidence-based practice; research methods; and training methods.

Specific responsibilities will likely include:

- Receive/extract large datasets, clean, and prepare data for analysis and reporting (e.g., identify missing data, identify and correct data entry errors, merge datasets).
- Develop and manipulate datasets (e.g. create formulas and calculations, develop and update scripts/syntax, merge across datasets), analyze data and identify trends using statistical software (e.g. SPSS, Excel, Power BI).
- Coordinate with community-based providers to answer questions and ensure accurate and timely data entry.
- Create and manage data systems used to collect provider-level data, including

working with data system developers.

- Produce reports on one or more grant- or contract-funded projects in children's behavioral health that include professional-quality tables, graphs, and figures and written interpretation of findings.
- Respond to ad hoc data analysis requests both internally and from stakeholders and translate findings into actionable steps or recommendations.
- Provide or support the delivery of feedback to clinical providers, school staff, and other state and community partners to support quality improvement processes.
- Communicate findings, in written and verbal formats, to internal and external stakeholders, which may include conducting data presentations to a variety of audiences as well as opportunities to co-author CHDI and/or peerreviewed publications.
- Regularly attend internal and external team meetings to update team on progress toward deliverables.
- Collaborate with team to translate findings into quality improvement and evaluation activities.
- Supervision of Data Analysts.
- Other duties as assigned.

Compensation

This is a full-time position with a salary range of \$70,000-78,000. Compensation will be determined based on candidate qualifications and includes a generous benefits package: 403b with employer contribution up to 10%, generous cost sharing of 85% of medical/dental insurance premiums including dependents, life insurance, long-term disability coverage, several ancillary/voluntary benefit plans, 9 paid holidays, up to 22 paid time off days, and paid sick time.
